

## RESOLUTION NO. 20-7

### **A RESOLUTION OF THE BOARD OF DIRECTORS OF THE ISLA VISTA COMMUNITY SERVICES DISTRICT CALIFORNIA CALLING FOR A DISTRICT ELECTION FOR THE PURPOSE OF ELECTING THREE (3) MEMBERS OF THE BOARD OF DIRECTORS, AND REQUESTING THE BOARD OF SUPERVISORS OF THE COUNTY OF SANTA BARBARA TO CONSOLIDATE THE DISTRICT ELECTION TO BE HELD ON TUESDAY, NOVEMBER 3, 2020, WITH THE STATEWIDE GENERAL ELECTION HELD ON THE SAME DATE, PURSUANT TO ELECTIONS CODE SECTION 10403**

**WHEREAS**, the Isla Vista Community Services District (“District”) was formed with a seven-member Board of Directors (“Board”) with five Directors selected at large, one Director appointed by the Board of Supervisors of the County of Santa Barbara, and one Director appointed by the Chancellor of the University of California, Santa Barbara, with terms of office set pursuant to Government Code section 61250; and

**WHEREAS**, Government Code section 61021(c) states that “elections and terms of office shall be determined pursuant to Uniform District Law, Part 4 (commencing with Section 10500) of the Elections Code”; and

**WHEREAS**, the District is a special district as defined in Elections Code section 10404; and

**WHEREAS**, the formation of the District established the election for its governing members in November of odd-numbered years; and

**WHEREAS**, on January 22, 2019, the Board adopted Resolutions 19-2 and 19-3 in order to move governance elections from odd-numbered years to even-numbered years, pursuant to Elections Code section 10404; and

**WHEREAS**, Resolutions 19-2 and 19-3 were submitted to the Santa Barbara County Board of Supervisors no later than 240 days prior to the scheduled election, pursuant to Elections Code section 10404; and

**WHEREAS**, pursuant to Government Code section 61250 and Elections Code section 10505(c), the Board was established with staggered terms of office for the Board, wherein the offices currently occupied by Directors Hedges and Nguyen having a term of four-years expiring in December of 2020; the office currently occupied by Director Bertrand having a term of two-years expiring in December of 2020; and the offices currently occupied by Directors Brandt, Freeman, Geis, and Thurlow having a term of four-years, expiring in December of 2022; and

**WHEREAS**, pursuant to Elections Code sections 10504 and 10509, the Board of Directors of the District hereby calls a General District Election to be held in the Isla Vista Community Services District, California, on November 3, 2020, for the purpose of

(a) electing two (2) members of the Board of Directors for a full term of four (4) years, with the offices to be filled are those currently occupied by Director Hedges and Director Nguyen, (b) electing one (1) member of the Board of Directors for a full term of two (2) years, with the office to be filled being that currently occupied by Director Bertrand, and (c) with candidates for said offices to pay for the publication of a statement of qualifications pursuant to Elections Code section 13307; and

**WHEREAS**, it is desirable that the General District Election be consolidated with the Statewide General Election to be held on the same date and that within the District the precincts, polling places, and election officers of the three (3) elections be the same, and that the Elections Division of the County Clerk, Recorder, and Assessor and Registrar of Voters of the County of Santa Barbara canvass the returns of the General District Election and that the election be held in all respects as if there were only one (1) election.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Directors of the Isla Vista Community Services District as follows:

1. The above recitals are true and correct and incorporated herein; and
2. Pursuant to the requirements of Elections Code section 10509, (a) the elective offices of the District to be filled at the next General District Election for full four (4) year terms shall be those offices currently held by Director Hedges and Director Nguyen, (b) the elective offices of the District to be filled at the next General District Election for two (2) year terms shall be those offices currently held by Director Bertrand, and (c) the candidates for said offices shall pay for the publication of a statement of qualifications pursuant to Elections Code Section 13307; and
3. Pursuant to the requirements of Elections Code section 10403, the Board of Supervisors of the County of Santa Barbara is hereby requested to consent and agree to the consolidation of a General District Election with the Statewide General election on Tuesday, November, 3, 2020, for the purpose of electing two (2) members of the Board of Directors for a full term of four (4) years, with the offices to be filled are those currently occupied by Director Hedges and Director Nguyen, and one member of the Board of Directors for a term of two (2) years, with the office to be filled being that currently occupied by Director Bertrand; and
4. The Elections Division of the County Clerk, Recorder, and Assessor and Registrar of Voters of the County of Santa Barbara is authorized to canvass the returns of the General District Election. The election shall be held in all respects as if there were only one (1) election, and only one (1) form of ballot shall be used. The election shall be held and conducted in accordance with Section 10418 of the Elections Code and in accordance with the applicable provisions of law regulating the election; and
5. The Board of Supervisors of Santa Barbara County is requested to issue instructions to the Elections Division of the County Clerk, Recorder, and Assessor and

Registrar of Voters to take any and all steps necessary for the holding of the consolidated election; and

6. The Isla Vista Community Services District recognizes that additional costs will be incurred by the County of Santa Barbara by reason of this consolidation and agrees to reimburse the County of Santa Barbara for the costs of such consolidation; and

7. That the General Manager is hereby directed to file a certified copy of this resolution with the Board of Supervisors and the Elections Division of the County Clerk, Recorder, and Assessor and Registrar of Voters, of the County of Santa Barbara, per Elections Code section 10504 and 10509.
